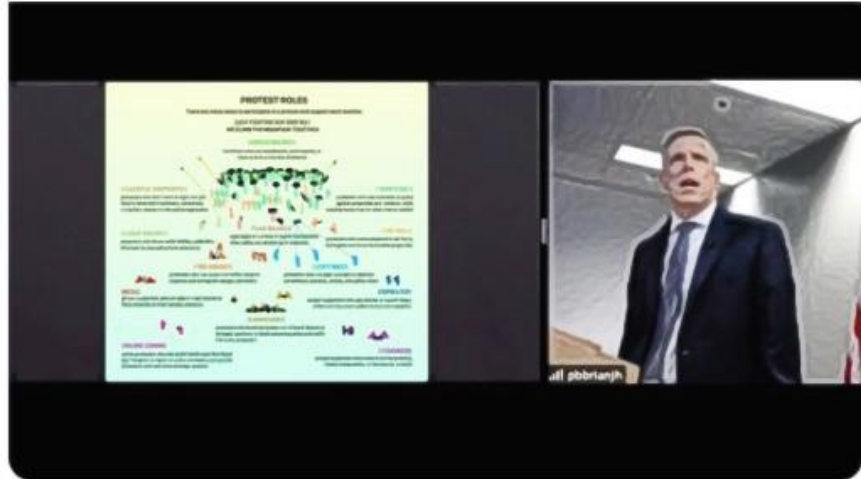

- ASK EVERYONE YOU INTERVIEW FOR PERMISSION TO RECORD THEM
- IDENTIFY YOURSELF AND YOUR MEDIA AFFILIATION FOR FACT CHECKING WITH THEM LATER AND/OR FURTHER INTERVIEWS WITH THEM

"NOTHING ABOUT US WITHOUT US"

- DO NOT EXPECT PEOPLE OF COLOR TO EXPLAIN EVERYTHING THAT WHITE PEOPLE NEED TO KNOW--YOU NEED TO DO YOUR OWN RESEARCH ABOUT THE ISSUES
- DO NOT ATTACK THE POLICE EITHER PHYSICALLY OR VERBALLY, ESPECIALLY WHEN PEOPLE OF COLOR ARE NEARBY



WHO CONTROLS THE NARRATIVE?

--It's our job to ensure that the issues behind the protest are not lost in the coverage of the protest itself

Finding Info Sources

- GO FIND *ALL* THE COPWATCHERS. NOT JUST ONE ORGANIZATION--FIND THEM ALL, AND SEE WHAT THEY HAVE TO SAY ABOUT LOCAL ISSUES, INCIDENTS AND KEY PLAYERS IN LAW ENFORCEMENT+LOCAL GOVERNMENT
- TAKE TIME TO TRACK WHITE SUPREMACIST ORGANIZATIONS, CLOCK WHO THEIR FIGUREHEADS ARE, AND IDENTIFY WHO IS LIKELY TO STEAL YOUR LIVESTREAM IMAGES FOR HIJACKED CONSERVATIVE CONTENT
- LOOK UP LOCAL PROTEST GROUPS AND FIND OUT WHO THE SPOKESPEOPLE/LEADERS ARE, OBTAIN THEIR CONTACT INFORMATION AND SPEAK WITH THEM IN ADVANCE OF THE EVENT



Finding Info Sources

- FIND OUT WHICH LEGAL OBSERVERS OR OTHER SERVICE PROVIDERS WILL BE VOLUNTEERING AT THE PROTEST, TRY TO GET THEIR CONTACT INFO BEFORE THE EVENT FOR FACTCHECKING LATER
- USE TWITTER, FB AND OTHER SOCIAL MEDIA TO ESTABLISH WHO ROUTINELY RUNS LIVESTREAMS OF DEMONSTRATIONS. CONNECT WITH THEM AND MAKE SURE YOU *CAN* ACCESS THEIR STREAMS FOR FACTCHECKING LATER
